Previous Roof Repairs – Flashing around chimney was repaired/resealed when Seller purchased the home in 2016. 4 Roofs, Inc. check out the master bedroom chimney and main living chimney in 2023. They resealed with application of high temp caulking and high temp coating to stucco at chimney cap base and chimney cap of the master bedroom chimney. They also resealed the living room chimney. They recommended replacement of the existing vent in the side of the chimney. This replacement was completed with a goose neck vent. There have been no known roof leaks to the best of seller's knowledge during their ownership.

Settling – There is evidence of settling in the upstairs laundry room/Kitchen ceiling. This occurred prior to Seller's purchase of the house. Seller has not seen any indication of further settling during their ownership.


